To: All Prospective Respondents:

This LOC is issued for the following reasons:

- I. Respond to questions submitted by prospective Respondents.
- II. Replace in its entirety Attachment B "Required Submittal Checklist" with "Attachment B Checklist (rev. 11.16.2021)".
- 1. **Question**: Will work under this contract preclude the prime contractor from bidding on follow on design work related to facility assessments or commissioning projects?

Response: Prime firms will not be awarded multiple prime contracts where there is a conflict. The decision to preclude will be determined on a case-by-case basis and will be dependent on various factors, and/or level of potential conflict.

2. **Question:** Other than Exhibit F, Attachment B M/WBE Letter of Intent, please advise which required City Documents are required of both the Prime proposer and subconsultants.
